

# EUROMARKET IN NOVARA

MAY 8, 9, 10 2009

## REGULATIONS

Confesercenti of Novara will organize the fifth edition of the EuroMarket

After the experience – which saw a great participation of European operators and public – it is necessary to focus some problems and some necessary rules for the participation, as follows:

1. The number of participants for each Delegation will remain the same as before; on the contrary, the area of the stands will be limited by precise outlined place for each operator; all that because of the precise area given at our disposal from the Major of Novara.
2. The area will be the same for each operator, different needs of space must be solved by each operator with his Delegation; in any case the total area destined to the Delegation itself may not be exceeded. **The sale of products as lingerie; shoes; leather bags; socks, stockings; underwear, training suits is strictly forbidden.**
3. The vehicles which will not be necessary for the activity are not allowed to park into the market-area; they have to be parked in a special area, which will be indicated by the Organisation.
4. The transport of goods from the parking to the market area will be at each operator's charge.
5. According to the Italian laws you have to have an Italian VAT number.
6. The Organisation will put at the participant's disposal the whole area of Via Turati - Viale delle Carrozze; the Organisation will cover the costs for:
  - Taxes on public area;
  - Taxes for urban waste disposal;
  - The construction and the management of a special electrical -system for the market ;
  - The promotion and advertising for the market;
  - The opening - cocktail . All the market operators will receive the participation- certificate.
7. It is absolutely necessary to attach the papers (clearly readable copy of passport/id card) together with the payment within the **10<sup>th</sup> April 2009**. The operators who haven't sent papers and not paid the participation fees cannot take part to the Market.
8. The Organisation will put at each operator's disposal in the market area an assistance service as follows:
  - A night and –day vigilance-service;
  - A special restaurant convention-service to obtain special prices in some restaurants situated near the market –area;
9. Please note that it will not be possible for us to supply structures and equipments as beach umbrellas, tables etc.

10. **IMPORTANT**. Please remind that the definitive list of the participants must be sent to the Organisation, together with the credit-transfer for the amount of 350,00 euro for organization contribution for each operator, within the **10<sup>th</sup> of April 2009**. The amount of 350,00 €uro must be considered as net. **The costs of bank transmission and other possible burocracy are totally at the participant's charge.**
